# INTERNATIONAL COMMITTEE OF THE RED CROSS (ICRC) COMPILED

## GUIDELINES FOR MILITARY MANUALS AND INSTRUCTIONS ON THE PROTECTION OF THE ENVIRONMENT IN TIMES OF ARMED CONFLICT

#### I. PRELIMINARY

- (1) The present Guidelines are drawn from existing international legal obligations and from State practice concerning the protection of the environment against the effects of armed conflict. They have been compiled to promote an active interest in, and concern for, the protection of the environment within the armed forces of all States.
- (2) Domestic legislation and other measures taken at the national level are essential means of ensuring that international law protecting the environment in times of armed conflict is indeed put into practice.
- (3) To the extent that the Guidelines are the expression of international customary law or of treaty law binding a particular State, they must be included in military manuals and instructions on the laws of war. Where they reflect national policy, it is suggested that they be included in such documents.

### II. GENERAL PRINCIPLES OF INTERNATIONAL LAW

(4) In addition to the specific rules set out below, the general principles of international law applicable in armed conflict—such as the principle of distinction and the principle of proportionality—provide protection to the environment. In particular, only military objectives may be attacked and no methods or means of warfare which cause excessive damage shall be employed. Precautions shall be taken in military operations as required by international law.

(5) International environmental agreements and relevant rules of customary law may continue to be applicable in times of armed conflict to the extent that they are not inconsistent with the applicable law of armed conflict.

Obligations relating to the protection of the environment towards States not party to an armed conflict (e.g., neighbouring States) and in relation to areas beyond the limits of national jurisdiction (e.g., the High Seas) are not affected by the existence

of the armed conflict to the extent that they are not inconsistent with the applicable law of armed conflict.

- (6) Parties to a non-international armed conflict are encouraged to apply the same rules that provide protection to the environment as those which prevail in international armed conflict and, accordingly, States are urged to incorporate such rules in their military manuals and instructions on the laws of war in a way that does not discriminate on the basis of how the conflict is characterized.
- (7) In cases not covered by rules of international agreements, the environment remains under the protection and authority of the principles of international law derived from established custom, from the principles of humanity and from the dictates of public conscience.

### III. SPECIFIC RULES ON THE PROTECTION OF THE ENVIRONMENT

(8) Destruction of the environment not justified by military necessity violates international humanitarian law. Under certain circumstances, such destruction is punishable as a grave breach of international humanitarian law.

(9) The general prohibition to destroy civilian objects, unless such destruction is justified by military necessity, also protects the environment.

In particular, States should take all measures required by international law to avoid:

(a)making forests or other kinds of plant cover the object of attack by incendiary weapons except when such natural elements are used to cover, conceal or camouflage combatants or other military objectives, or are themselves military objectives;

(b)attacks on objects indispensable to the survival of the civilian population, such as foodstuffs, agricultural areas or drinking water installations, if carried out for the purpose of denying such objects to the civilian population;

(c)attacks on works or installations containing dangerous forces, namely dams, dikes and nuclear electrical generating stations, even where they are military objectives, if such attack may cause the release of dangerous forces and consequent severe losses among the civilian population and as long as such works or

installations are entitled to special protection under Protocol I additional to the Geneva Conventions;

(d)attacks on historic monuments, works of art or places of worship which constitute the cultural or spiritual heritage of peoples.

(10) The indiscriminate laying of landmines is prohibited. The location of all pre-planned minefields must be recorded. Any unrecorded laying of remotely delivered non-self-neutralizing landmines is prohibited. Special rules limit the emplacement and use of naval mines.

(11) Care shall be taken in warfare to protect and preserve the natural environment. It is prohibited to employ methods or means of warfare which are intended, or may be expected, to cause widespread, long-term and severe damage to the natural environment and thereby prejudice the health or survival of the population.

(12) The military or any other hostile use of environmental modification techniques having widespread, long-lasting or severe effects as the means of destruction, damage or injury to any other State party is prohibited. The term "environmental modification techniques" refers to any technique for changing—through the deliberate manipulation of natural processes—the dynamics, composition or structure of the Earth, including its biota, lithosphere, hydrosphere and atmosphere, or of outer space.

(13) Attacks against the natural environment by way of reprisals are prohibited for States party to Protocol I additional to the Geneva Conventions.

(14) States are urged to enter into further agreements providing additional protection to the natural environment in times of armed conflict.

(15) Works or installations containing dangerous forces, and cultural property shall be clearly marked and identified, in accordance with applicable international rules. Parties to an armed conflict are encouraged to mark and identify also works

or installations where hazardous activities are being carried out, as well as sites which are essential to human health or the environment.

### IV. IMPLEMENTATION AND DISSEMINATION

(16) States shall respect and ensure respect for the obligations under international law applicable in armed conflict, including the rules providing protection for the environment in times of armed conflict.

(17) States shall disseminate these rules and make them known as widely as possible in their respective countries and include them in their programs of military and civil instruction.

(18) In the study, development, acquisition or adoption of a new weapon, means or method of warfare, States are under an obligation to determine whether its employment would, in some or all circumstances, be prohibited by applicable rules of international law, including those providing protection to the environment in times of armed conflict.

(19) In the event of armed conflict, parties to such a conflict are encouraged to facilitate and protect the work of impartial organizations contributing to prevent or repair damage to the environment, pursuant to special agreements between the parties concerned or, as the case may be, the permission granted by one of them. Such work should be performed with due regard to the security interests of the parties concerned.

(20) In the event of breaches of rules of international humanitarian law protecting the environment, measures shall be taken to stop any such violation and to prevent further breaches. Military commanders are required to prevent and, where necessary, to suppress and to report to competent authorities breaches of these rules. In serious cases, offenders shall be brought to justice.

He is Editor-in-Chief of the American Journal of International Law, a member of the Council on Foreign Relations of the American, and French, Societies of International Law, and of the Council of the International Institute of Humanitarian Law (San Remo). Professor Meron's books include Human Rights Law-Making in the United Nations and Human Rights and Humanitarian Norms as Customary Law.

Professor John Norton Moore is the Director, Centers for Oceans Law and Policy and National Security Law, and the Walter L. Brown Professor of Law, University of Virginia. He served on active duty with the U.S. Navy from 1965-68 as a member of the Judge Advocate General's Corps. He has served on the Board of Editors of the American Journal of International Law, the Executive Council of the American Society of International Law, and the Executive Board (and Presiding Officer) of the Law of the Sea Institute. He has co-edited Law of the Sea: U.S. Policy Dilemma and The 1982 Convention on the Law of the Sea. His numerous articles and papers include "Environmental Protection in Archipelagic Seas and International Straits: The Role of the International Maritime Organization."

Dr. Glen Plant is with the London School of Economics and Political Science where he has served since 1991 as the Director of the LSE Centre for Environmental Law and Policy, the first major activity of which was the London Conference on "A 'Fifth Geneva' Convention on the Protection of the Environment in Time of Armed Conflict." The proceedings and a commentary were published in the book Environmental Protection and the Law of War. Dr. Plant has taught at the Fletcher School of Law and Diplomacy, Tufts University and served as an Assistant Legal Adviser in the Foreign and Commonwealth Office.

Captain (Sel.) John P. Quinn, JAGC, U.S. Navy, has served in the U.S. Navy for 21 years, since 1982 as a member of the Judge Advocate General's Corps. He is currently serving as Environmental Counsel to the Director, Chief of Naval Operations Environmental Protection, Safety and Occupational Health Division. His naval service has included assignments on board USS Farragut and USS Theodore Roosevelt, as Aide to the Vice Commander, Naval Supply Systems Command, as Environmental Counsel to the Commander in Chief, U.S. Pacific Fleet, and as Pacific Fleet Environmental Officer.

Captain J. Ashley Roach, JAGC, U.S. Navy (Ret.), is an attorney in the Office of the Legal Adviser, U.S. Department of State, with responsibility for the law of the sea and the law of naval warfare. He retired from the U.S. Navy in 1992 with the rank of Captain, Judge Advocate General's Corps, after 28 years of service. His articles on the law of war include "Developments in the Law of Naval Warfare: Custom or Codification" and "Missiles on Target: The Law of Targeting and The Tanker War." He is the co-author of Excessive Maritime Claims, published as Volume 66 of the Naval War College's International Law Studies (the "Blue Book" series). Recently he was among a group of academics and naval experts that worked together to produce the San Remo Manual on International Law Applicable to Armed Conflicts at Sea.

Professor Adam Roberts is the Montague Burton Professor on International Relations at Oxford University and a Fellow of Balliol College. He has been a Lecturer in International Relations at the London School of Economics and Political Science and the Alastair Buchan Reader in International Relations and Fellow of St. Antony's College, Oxford. His several books include co-editing Documents on the Law of War. He is now working on Occupation, Resistance and Law: International Law on Military Occupations and on Resistance. He is the author of numerous articles.

Rear Admiral Horace B. Robertson, Jr., JAGC, U.S. Navy, (Ret.), served 31 years on active duty with the U.S. Navy, first as a general line officer (surface warfare) and later as a law specialist and judge advocate. Included among his assignments were tours as Commanding Officer of an amphibious landing ship, Special Counsel to the Secretary of the Navy, Special Counsel to the Chief of Naval Operations, and Judge Advocate General of the Navy. Following retirement, Rear Admiral Robertson was appointed Professor of Law at Duke University School of Law, where he assumed Emeritus status in 1990. He is the editor of The Law of Naval Operations, Volume 64 of the Naval War College's International Law Studies (the "Blue Book" series). Recently he was among a group of academics and naval experts that worked together to produce the San Remo Manual on International Law Applicable to Armed Conflicts at Sea. During 1991-92, he served as the Charles H. Stockton Professor of International Law at the Naval War College.

Professor Ivan Shearer is the Challis Professor of International Law in the University of Sidney. Formerly Professor of Law and Dean of the Faculty of Law in the University of New South Wales, he was awarded the title of Professor Emeritus in 1993. He has been a Visiting Fellow, All Souls College, Oxford, and held visiting appointments at universities in Germany and Greece. Professor Shearer is the Director of Studies, International Law Association (Australian Branch), and on the editorial board of three professional journals. He is a member of the International Institute of Humanitarian Law, San Remo, and was among a group of academics and naval experts that worked together to produce the San Remo Manual on International Law Applicable to Armed Conflicts at Sea. He holds the rank of Captain in the Royal Australian Naval Reserve, and in that capacity gives advice within the Department of Defence and frequent lectures on the law of the sea and international law to various service bodies.

Rear Admiral James R. Stark, U.S. Navy, is the President, Naval War College, having assumed that position in June 1995. He is a graduate of the U.S. Naval Academy, studied at the University of Vienna as a Fulbright Scholar, and holds a Doctorate in Political Science from the Fletcher School of Law and Diplomacy, Tufts University. Rear Admiral Stark's afloat assignments include command of a frigate, USS Julius A. Furer, and cruiser, USS Leahy. His shore assignments include assignments in Washington on the Navy Staff, the National Security Council, and as Executive Director of the Chief of Naval Operations Executive Panel. He has served as the Commander, Training Command, U.S. Pacific Fleet. Immediately

prior to reporting to the Naval War College, Admiral Stark commanded the NATO Standing Naval Force Atlantic.

Professor Paul C. Szasz retired in 1989 having served with the United Nations as the Principal Legal Officer; Director, General Legal Division; and also Deputy to the Legal Counsel. He had earlier served with the International Atomic Energy Commission, the World Bank, and as Secretary of the International Centre for Settlement of Investment Disputes. Professor Szasz has taught at various times at Pace University School of Law, the University of California, Berkeley, and as a Visiting Fellow on Environmental Law and Adjunct Professor of International Law at the Center for International Studies, New York University School of Law. He has been a participant in numerous international legal conferences and symposia, particularly in the area of international environmental law, and has authored some 100 studies on international law, the settlement of international disputes, and related topics.

Dr. Gerard J. Tanja is the General Director of the T.M.C. Asser Institute for International Law in The Hague, the Netherlands. He taught public international law at the University of Leyden and from 1990-94 served as the Legal Adviser to the Netherlands Government in the Ministry of Foreign Affairs. Dr. Tanja's published works include Protection of the Environment in Times of Armed Conflict: The Iran-Iraq War in the Netherlands International Law Review. A forthcoming book is The War Crimes Tribunal for the Former Yugoslavia: Commentary and Selected Documents.

Colones James P. Terry, U.S. Marine Corps (Ret.), is the Deputy Director of the Office of Hearings and Appeals for the U.S. Department of the Interior. He also serves as Director of the Hearings Division with oversight responsibility over all Administrative Law Judges within the Department. Prior to his current appointment, Colonel Terry served as an officer in the U.S. Marine Corps for 27 years. His tours as an infantry officer included service as a Platoon Commander in Vietnam. As a judge advocate, his assignments included service as a Military Judge, Division Staff Judge Advocate, and Marine Expeditionary Force Staff Judge Advocate. Immediately prior to his retirement as a Colonel, he served as Legal Counsel to the Chairman, Joint Chiefs of Staff. Colonel Terry is widely published in the areas of international law, coercion control, and protection of the environment during armed conflict.

Professor Wil D. Verway is a Professor of International Law and the Law of International Organizations, University of Groningen, the Netherlands. He has been a Guest Professor of International Law at universities in Argentina, Belgium, Kenya, Indonesia, Netherlands Antilles, and Tanzania. Professor Verway is the author of several advisory reports to the United Nations Secretary-General, the Netherlands Minister of Foreign Affairs, several governments in Europe, Africa and Asia, and has been a representative of the Netherlands Government in General Assembly Sessions and in other negotiations. He is the author of five books and

over 60 articles dealing, in particular, with legal aspects of International Peace and Security, International Economic Relations and Developing Cooperation, and Environment Protection.

Mr. Gary D. Vest is Principal Assistant Deputy Under Secretary of Defense for Environmental Security, U.S. Department of Defense. He assists and acts for the Deputy Under Secretary in establishing policy for, and overseeing implementation of, all worldwide environmental matters of the Department of Defense. He has extensive service with the Air Force, including positions as the Deputy Assistant Secretary of the Air Force for Environment, Safety and Occupational Health, and Assistant to the Chief of the Air Force Environmental Division. Since 1980, he has participated extensively in NATO environmental matters and currently chairs or co-chairs three NATO environmental groups. He chairs the Defense Environment, Safety and Occupational Health Policy Board and the Defense Environmental Security International Activities Committee. Mr. Vest has published widely and has extensive policy experience in other matters such as natural and cultural resources, explosive ordnance disposal, training ranges and munitions storage.

Dr. Raul E. Vinuesa is a Full Professor of Public International Law and Full Professor of Human Rights at the University of Buenos Aires, a Full Professor of International Law at the Institute for the Foreign Service of the Nation, Ministry of Foreign Affairs and the Argentine Naval War College, and the President of the Center of International Studies of Buenos Aires. Professor Vinuesa is the President of the Arbitration Tribunal of the Argentina and Uruguay Commission on the Uruguay River and a member of the Arbitration Tribunal for MERCOSUR. He serves as a Special Legal Adviser on International Law at the General Attorney's Office and Special Legal Adviser on International Human Rights Issues to the Ministry of Justice. Since 1992, Professor Vinuesa has been a member of the Group of Experts on Environmental Law and Humanitarian Law of the International Committee of the Red Cross. He is a Board member or official of several associations, including the Argentine Association of Comparative Law.

Professor George K. Walker is a Professor of Law at Wake Forest University, Winston-Salem, North Carolina. He is a retired line Captain in the U.S. Naval Reserve, having commanded six Naval Reserve units. He has authored or edited over 10 books, 20 articles or book chapters, and 20 continuing education chapters. Recently, he was among a group of academics and naval experts that worked together to produce the San Remo Manual on International Law Applicable to Armed Conflicts at Sea. During 1992-93, Professor Walker served as the Charles H. Stockton Professor of International Law at the Naval War College.

Rear Admiral William H. Wright, IV, U.S. Navy, is the Assistant Deputy Chief of Naval Operations (Plans, Policy and Operations). A graduate of the U.S. Naval Academy, Admiral Wright has had numerous afloat tours including Commanding Officer, USS *Antrim*; Commander, Destroyer Squadron TWENTY; and

Commander, Cruiser Destroyer Group TWELVE. He had command of the Wasp Amphibious Task Force during the intervention in Cap Haitien, Haiti in September 1994. His ashore tours include assignments to the National Security Council Staff as Director of Defense Programs; Commanding Officer, U.S. Naval Station, Subic Bay, Republic of the Philippines; and to the Arms Control and Disarmament Agency, where he served as Executive Secretary to the U.S. SALT Delegation in Geneva.
