Professor M. Cherif Bassiouni is a Professor of Law, De Paul University College of Law. He has also served as President, International Human Rights Law Institute, De Paul University College of Law; President, International Association of Penal Law; President, International Institute of Higher Studies in Criminal Sciences; Former Chairman, Commission of Experts Established Pursuant to Security Council Resolution 780 (1992) to Investigate Violations of International Humanitarian Law in Former Yugoslavia; Vice-Chairman, Ad Hoc Committee on the Establishment of an International Criminal Court; Vice-Chairman, Preparatory Committee for the Establishment of an International Criminal Court; Chairman, Drafting Committee, Diplomatic Conference of Plenipotentiaries for the Establishment of an International Criminal Court.

Professor Ove Bring is Professor of International Law at Stockholm University and at the National Defence College, Stockholm. He is Chairman of the Swedish Branch of the International Law Association and has served as Special Legal Adviser at the Ministry for Foreign Affairs. He participated in the Thomson/Blackwell humanitarian mission to Former Yugoslavia, reporting to the Committee of Senior Officials of the Conference on Security and Cooperation in Europe (CSCE) (1992–1993). In 1994 he headed a Swedish human rights mission to China and Tibet, reporting to the Swedish Ministry for Foreign Affairs. In February 1995 he was appointed Swedish Conciliator under the European Convention on Conciliation and Arbitration within the CSCE, now The Organization for Security and Cooperation in Europe (OSCE). In May 1998, he was appointed a Swedish Member of the Permanent Court of Arbitration in The Hague.

Professor Bin Cheng, Licencié-en-droit, Ph.D., LL.D., Hon. LL.D., Fellow of the Royal Aeronautical Society, is Emeritus Professor of Air and Space Law at the University of London, and Visiting Professor of Law at the University of Detroit Mercy. He is an Officier of France's Ordre des Palmes Académiques;

holder of Brazil's Santos Dumont Merit Medal; a Fellow of University College London; and recipient of the International Astronomical Federation's International Institute of Space Law Lifetime Achievement Book Award "in recognition of his extraordinary, authoritative, and lasting contributions to the progressive development of international law, air and space law"; and of the International Air Transport Association's Certificate of Appreciation "for his outstanding contribution to the progressive development of international air law," and he has been Dean and Chairman of the Board of Studies of London University's Faculty of Laws; Chairman of the Air Law Committee of the International Law Association: Hon. Secretary of the British Branch of the International Law Association. Professor Cheng is the author of GENERAL PRINCIPLES OF LAW AS APPLIED BY INTERNATIONAL COURTS AND TRIBUNALS (London 1953; Grotius Classic Reprints Series No. II, Cambridge, 1987), THE LAW OF INTERNATIONAL AIR TRANSPORT (London and New York, 1962), STUDIES IN INTERNATIONAL SPACE LAW (Oxford, 1997), and some 250 articles on international law, air law and space law, as well as the contributing editor of IN-TERNATIONAL LAW: TEACHING AND PRACTICE (London, 1982) and joint contributing editor with E.D. Brown of CONTEMPORARY PROBLEMS OF IN-TERNATIONAL LAW: ESSAYS IN HONOUR OF GEORG SCHWARZENBERGER ON HIS EIGHTIETH BIRTHDAY (London, 1988).

Professor Anthony D'Amato is the Judd and Mary Morris Leighton Professor of Law at Northwestern University School of Law, a position he has held since 1990. An active litigator in international human rights, he was the first American lawyer to argue (and win) a case before the European Court of Human Rights in Strasbourg. Professor D'Amato also litigated the only court of appeals victory against the government in a military service case during the Vietnam era. He is the author of over 20 books and over 110 articles, including ANALYTIC JURISPRUDENCE ANTHOLOGY and INTRODUCTION TO LAW AND LEGAL THINKING.

Dr. Yoram Dinstein is Pro-President and Professor of International Law at Tel Aviv University, Israel. He is a member of the Institut de Droit International and the author of many books, as well as over 100 articles. Dr. Dinstein is the editor of the ISRAEL YEARBOOK OF HUMAN RIGHTS and has been a visiting professor at New York University and the University of Toronto. He has also served as Consul of Israel in New York and occupied the Charles H. Stockton Chair of International Law at the U.S. Naval War College.

Mr. William J. Fenrick is the Senior Legal Advisor and Head of the Legal Advisory Section in the Office of the Prosecutor for the International Criminal Tribunal for the former Yugoslavia. As such, he is responsible for advising the

Office of the Prosecutor on all law of armed conflict matters. Previously, he was a member of the Commission of Experts appointed under Security Council Resolution 780 to investigate allegations of serious violations of international humanitarian law and served as rapporteur for legal issues and for on-site investigations. Mr. Fenrick retired from the Canadian military in 1994. During his military career, he specialised in and published several articles on the law of armed conflict.

Doctor Dieter Fleck is the Director, International Agreements and Policy, Federal Ministry of Defence, Germany. Dr. Fleck's previous positions were as Director, International Legal Affairs, Federal Ministry of Defense; Assistant Head of Section in the Federal Chancellor's Office; and Legal Advisor in the Federal Armed Forces. He is a member of the Council, International Institute of Humanitarian Law, San Remo; Vice President, International Society of Military Law and the Law of War, Brussels; and Rapporteur, Committee of Arms Control and Disarmament Law of the International Law Association. He has written and edited numerous publications including THE HANDBOOK OF HUMANITARIAN LAW IN ARMED CONFLICTS.

Professor Christopher Greenwood is Professor of International Law at the London School of Economics and Political Science. He is a Barrister, practicing from Essex Court Chambers in London, and has represented the United Kingdom before the International Court of Justice in the Nuclear Weapons and Lockerbie cases, as well as appearing regularly in the English courts. Professor Greenwood was formerly a Fellow and Lecturer at Magdalene College, Cambridge, and has been a visiting professor at universities in the United States and Germany. He is a regular lecturer at military colleges, has published a number of articles on international law, and is the author of a forthcoming book on the law of armed conflict.

Doctor Wolff Heintschel von Heinegg is Professor of Law at the University of Augsburg, Germany. The Rapporteur of the International Law Association Committee on Maritime Neutrality and the Vice-President of the German Society of Military Law and the Law of War, Dr. Heintschel von Heinegg was among a group of international lawyers and naval experts who produced the SAN REMO MANUAL ON INTERNATIONAL LAW APPLICABLE TO ARMED CONFLICTS AT SEA. He is a widely published author of articles and books on the law of the sea and naval warfare.

Professor Ruth Lapidoth is Professor of International Law at the Faculty of Law and at the Department of International Relations, as well as chairperson of the Academic Committee of the Institute for European Studies, at the Hebrew University of Jerusalem. Since 1989 she has been a member of the Permanent

Court of Arbitration in The Hague. Professor Lapidoth has taught and done research at various institutions in Europe and the United States, including the Universities of Paris, Geneva, Oxford, New York University, Duke, and Georgetown, the Woodrow Wilson Center, and the United States Institute of Peace. She has represented Israel in various international conferences, was the Legal Adviser to Israel's Ministry of Foreign Affairs (1979–1981), and served as a member of the arbitration panel that settled the Taba dispute between Egypt and Israel. Professor Lapidoth is the author of eight books and more than seventy articles dealing with questions of international law, the law of the sea, human rights, the Arab-Israel conflict and its resolution, autonomy, and Ierusalem.

Professor Howard S. Levie graduated from Cornell University with his A.B. in 1928; J.D., Cornell Law School, 1930; and LL.M., George Washington University Law School, 1957. He is a Colonel (retired) in The Judge Advocate General's Corps, U.S. Army; Distinguished Member of The Judge Advocate General's Corps Regiment, 1995; Professor of Law, Saint Louis University Law School, 1963–1977; Professor Emeritus of Law, Saint Louis University Law School since 1977; Charles H. Stockton Chair of International Law, U.S. Naval War College, 1971–1972; Lecturer, Salve Regina University, 1984–1988; and Adjunct Professor of International Law, U.S. Naval War College since 1991. Honored by the establishment of the Howard S. Levie Military Chair of Operational Law at the Naval War College in 1994 and by the publication in 1998 of Levie on the Law of War as Volume 70 of the U.S. Naval War College's International Law Studies series.

Professor Ronald St. J. Macdonald is Professor of International Law, University of Toronto. Between 1980 and 1998 he served as a judge at the European Court of Human Rights in Strasbourg. He is an Honorary Professor in the Law Department of Peking University, an Honorary Member of the American Society of International Law and a Membre de d'Institut de droit international.

Professor Theodor Meron received his legal education at the University of Jerusalem, Harvard University and Cambridge. Since 1978 he has been Professor of International Law at NewYork University School of Law, specializing in human rights, humanitarian law, international criminal law, and law and literature. Between 1991 and 1995 he was also Professor of International Law at the Graduate Institute of International Studies in Geneva. In 1994 he was named to the Charles L. Denison Chair at the NYU Law School. He was Editorin-Chief of the American Journal of International Law (1993–1998) and is a member of the Board of Editors. Professor Meron is also a member of the Council on Foreign Relations, of the American and French Societies of

International Law, and of the Bar of the State of New York. He served as a member of the United States Delegation to the Rome conference on the establishment of an International Criminal Court. He has lectured extensively around the world, and published widely, including seven books and numerous articles. Professor Meron is an acknowledged expert on the law of war in the Elizabethan age.

Professor Ved Nanda is the Thompson B. Marsh Professor of Law and Director of the International Legal Studies Program at the University of Denver College of Law. Since 1992 he has served as the John Evans University Professor, and since 1994, as Vice Provost for Internationalization. Currently he is President of the World Jurist Association, honorary vice president of the American Society of International Law, and a member of the advisory council of the United States Institute of Human Rights. He is the United States Delegate to the World Federation of the United Nations Associations, Geneva, where he is Vice Chair and Member of the Executive Committee. In Beijing, China, he was presented with the "World Legal Scholar" Award by the World Jurist Association, and an honorary doctorate has been conferred upon him by Soka University in Tokyo. He is widely published in law journals and national magazines, has authored or co-authored 16 books in the various fields of international law, and has been a Distinguished Visiting Professor/Scholar at a number of universities.

Mr. W. Hays Parks, Colonel, United States Marine Corps Reserve (Retired), is Special Assistant to The Judge Advocate General of the United States Army for Law of War Matters. He has also occupied the Naval War College's Charles H. Stockton Chair of International Law and is Adjunct Professor at both George Washington University School of Law and American University School of Law. The legal adviser for the 1986 air strike against terrorist-related targets in Libya, Mr. Parks also had primary responsibility for the investigation of Iraqi war crimes during its 1990–1991 occupation of Kuwait. He has served as a United States representative for law of war negotiations in New York, Geneva, The Hague, and Vienna. A frequent lecturer on the law of military operations at the National, Army, Air Force and Naval War Colleges, the service staff colleges, and other service schools such as the Navy Fighter Weapons School ("Top Gun"), Mr. Parks is widely published in military and legal journals. In 1990 he was the United States Naval Institute's Author of the Year. Mr. Parks served in the Republic of Vietnam and earned Navy-Marine Corps wings, Canadian and British parachutist wings, U.S. Army Master Parachutist wings, and 82nd Airborne Centurion wings during his military career.

The Honorable Shabtai Rosenne is Ambassador of Israel (retired); Legal Advisor, Israel Foreign Ministry, 1948–1967; Deputy Permanent Representative of Israel to the United Nations (New York), 1967–1971; and Permanent Representative to the International Organizations in Geneva, 1971–1974; Ambassador-at-Large, 1974–1983; member of the International Law Commission, 1962–1971; member of the U.S. Delegation to the International Court of Justice in the ELSI case (1989); Honorary member, American Society of International Law and recipient of its Certificate of Merit; Member of the Institute of International Law and 3rd Vice-President (1997–1999); Honorary President, Israel Branch of the International Law Association; Visiting Professor at Bar Ilan, Cambridge (England), Utrecht and Amsterdam Universities, and Visiting Scholar and Faculty Adjunct, University of Virginia School of Law. Ambassador Rosenne was awarded the Manley O. Hudson medal in 1999.

Professor Alfred P. Rubin is Distinguished Professor of International Law at The Fletcher School of Law & Diplomacy, Tufts University. He served in 1981–1982 as the Charles H. Stockton Professor of International Law at the Naval War College and is currently President of the International Law Association's American Branch. His Naval War College "Blue Book," THE LAW OF PIRACY is now in its second edition. His latest book, ETHICS AND AUTHORITY IN INTERNATIONAL LAW, was published by the University of Cambridge Press in 1997.

Ambassador Dr. Robbie Sabel is a Visiting Professor at the Faculty of Law and at the Department of International Relations of the Hebrew University, Jerusalem. He served for eight years as the Legal Adviser to the Israeli Ministry of Foreign Affairs and later as Deputy Director General for Arms Control and Disarmament of the Ministry. He was a member of Israel's delegation to the Geneva Humanitarian Law Conference. Ambassador Sabel is the author of the book PROCEDURE AT INTERNATIONAL CONFERENCES, published by Cambridge University Press, which received the 1997 annual award for merit from the American Society of International Law. He is Vice President of the Israel branch of the International Law Association.

Professor Michael Schmitt is Professor of International Law, George C. Marshall European Center for Security Studies in Garmisch-Partenkirchen, Germany. He has previously served on the faculties of the United States Air Force Academy and United States Naval War College, and currently is an adjunct faculty member of both the NATO (SHAPE) School at Oberammergau, Germany, and the International Institute of Humanitarian Law in San Remo, Italy. Professor Schmitt is a retired Air Force judge advocate and former Visiting Scholar at Yale Law School. He is the contributing editor of numerous

books, including three in the Naval War College's "Blue Book" series, and has authored many articles on international law and military operations.

Professor Georg Schwarzenberger joined the faculty of University College London as a lecturer in International Law in 1938. He went on to serve the University as Professor, Sub-Dean, Vice-Dean and Dean of Law before being named Professor Emeritus in 1975. During his distinguished career, Professor Schwarzenberger held a number of prominent positions, including Director and Vice-President of the London Institute of World Affairs, the International Law Association's Rapporteur for the Committee on the United Nations, and Member of the Permanent Finnish-Netherlands Conciliation Commission. He served as the editor of such publications as THE YEAR BOOK OF WORLD AFFAIRS AND CURRENT LEGAL PROBLEMS, and authored countless articles and many books. Among his most noteworthy are POWER POLITICS, A MANUAL OF INTERNATIONAL LAW, and the four-volume collection, INTERNATIONAL LAW. Professor Schwarzenberger passed away in 1991, having mentored a number of scholars who rose to international prominence, including Professor Leslie Green.

Professor Paul C. Szasz is currently an Adjunct Professor at the Center for International Studies, New York University School of Law, and has served as a Visiting Professor at the Law Schools of the University of California at Berkeley and the University of Georgia. Since 1958 he has been a member of the legal offices of the International Atomic Energy Agency (IAEA), the World Bank, and the United Nations, where he served as Director of the General Legal Division and Deputy to the Legal Counsel. After retirement he served as Legal Adviser to the United Nations Transition Assistance Group in Namibia and to the International Conference on the Former Yugoslavia, and as Acting Director of the Office of the UN Legal Counsel and again as Deputy to the Legal Counsel. In his several official assignments he served as Legal Adviser to numerous conferences, including to the 1979–1980 UN Conference on Inhumane Weapons. Professor Szasz has also been a participant in numerous academic conferences and symposia, and has authored over 100 studies in the areas of IAEA safeguards, peacekeeping operations, the settlement of international disputes, the protection of the environment, international administrative law, and related topics.

Professor Sharon A. Williams is Professor of International Law and International Criminal Law at Osgoode Hall Law School, York University, Toronto, where she has taught since 1977. Currently the Immediate Past President of the Canadian Council on International Law, she was a member of the Permanent Court of Arbitration, The Hague (1991–1997), and since 1993 has been a

Fellow of the Royal Society of Canada. Professor Williams has been an advisor with the Canadian delegation at the United Nations, in the Sixth Committee of the General Assembly, and has acted as a consultant to the Canadian Department of Justice on international criminal law matters including extradition, the establishment of a permanent international criminal court and a draft code of crimes against the peace and security of humankind, and to the 1985 Deschênes Commission of Inquiry on War Criminals in Canada. She attended the 1998 United Nations Conference on the Establishment of an International Criminal Court in Rome and the subsequent Preparatory Commission meetings. Professor Williams has authored, co-authored and contributed to many books as well as written many journal articles in the fields of public international law and international criminal law.
